

## Arts in Corrections NYS Application Preview: Organization

Arts in Corrections NYS facilitates and supports arts programming inside Department of Corrections and Community Supervision (NYS DOCCS) facilities across New York State. A regrant program of the New York State Council on the Arts (NYSCA), Arts in Corrections is facilitated by Wave Farm, a nonprofit New York State arts organization, working closely with DOCCS.

In 2023 and 2024, Arts in Corrections supported arts programming inside approximately 10 NYS facilities across New York State. In 2025, with the support of NYSCA and DOCCS, Arts in Corrections will expand to 15 facilities across New York State. Teaching artists facilitate in-person workshops, providing system-impacted individuals with once-a-week programming in a variety of disciplines including the visual arts, electronic media/film, music, and literature.

Arts in Corrections is currently accepting applications for new workshops in five DOCCS facilities: Albion, Cayuga, Eastern, Mid-State, and Wyoming.
